ORDER

Whereas, the Hon'ble High Court of Delhi vide Judgment dated 19.01.2016 in the Writ Petition No. 4109/2013 in the matter of "Justice for All versus GNCTD and Others" has directed the Director of Education to ensure the compliance of the terms, if any, in the letter of allotment regarding the increase of the fee by all the Private Unaided Recognized Schools which are allotted land by DDA/other landowning agencies.

And Whereas, all the Private Unaided Recognized Schools, recognized by the Director of Education, Govt. of NCT of Delhi under the provisions of Delhi Education Act & Rules, 1973 are statutorily bound to comply with the provisions of the DSEAR, 1973 and RTE Act, 2009 as well as the directions/guidelines issued by the Director of Education from time to time.

Now, therefore, all the Head of Schools / Managers of Private Unaided Recognized Schools, allotted land by the land owning agencies on the condition of seeking prior sanction of Director of Education for increase in fee, are directed to submit their proposals, if any, for prior sanction of the Director of Education for increase in fee for the academic session 2023-24 (through the separate link on the online module of the department), through the website of the Directorate. The fee hike proposal must be submitted only through online module available on DOE's website i.e. **www.edudel.nic.in** starting w.e.f. 06.03.2023 (Monday) upto 27.03.2023 (Monday). Any incomplete proposal submitted by the schools shall be instantly rejected without any hearing. Further, no manual submission of fee hike proposal by any school shall be considered.

Further, the Private Unaided Recognized Schools are directed to submit the complete set of documents/ financial records as well as subsequent clarification timely, in one go, so that the fee hike proposals of the schools can be disposed in time bound manner.

The proposals submitted by the schools shall be scrutinized/ examined by the Director of Education through any officer or team authorized in this behalf. All such schools are strictly directed not to increase any fee until the sanction is conveyed to their proposal by Director of Education. In case, no proposal is submitted by the school in response to this order, the school shall not increase its fee for the academic session 2023-24. Any complaint regarding increase of any fee without such prior approval will be viewed seriously and action shall be taken as per the statutory provisions and directions of the Hon'ble High Court including a request to DDA for cancellation of lease deed executed in favour of the defaulter school's Society.



The link of module to submit the online proposals and upload the documents and financial statements shall be activated on the website of the Directorate i.e. Login">www.edudel.nic.in>Login ID>School Plant>Proposal for fee hike for the academic session 2023-24 through school login and password.
